Annual subscription

The annual subscription for 2017-2018 is £22, comprising £20 for membership* of the Royal Scottish Country Dance Society (RSCDS) and £2 for membership of Bristol Branch. (All members must be members of RSCDS, and members of the local branch)

(* RSCDS Youth membership is £10 up to age 17, and £16 age 18 – 24)

Joint membership is £36 comprising £32 for RSCDS and £4 for Bristol Branch.

(joint members will receive only one copy of the RSCDS magazine).

The Bristol branch subscription for RSCDS members from other areas is £2 each
